As Vice-President, my primary interest over this past year has been the anticipated changes in organizational structure and governance at the National, MSC level and, following that, at the Provincial MSO level. It is important that we have a structure in place that responds to and reflects the needs and interests of Masters swimmers and their local clubs. Without them, Masters swimming would not exist. I expect that the anticipated legislative changes in Ontario will require us to reconsider and revise our structure and to develop plans to address any budgetary surpluses that arise. I foresee my role as continuing to support the President and the Board in dealing with these governance issues over the next few years.

TREASURER'S REPORT - 2011-2012 - Cathy Macdonald

2011-12 year was another busy year for Masters Swimming Ontario. The other reports from board and staff members have outlined many of the initiatives that were underway during this past year. □Club and member's fees are staying fairly stable over the last few years. Many expenses/disbursements were close to budget. Travel expenses were less than expected however these fees are somewhat dependent on where board members live and where the face to face meetings are held. Teleconferences do help reduce these costs. Some legal fees were incurred that were not originally budgeted for this year as outlined in other board reports. Our website redesign project is an active project however only the first installment for the work has been paid to date. The Board did provide partial reimbursement of costs to two MSO members who were selected to officiate at the Worlds this past summer in Riccione.

MSO need bids for the 2014 Provincials and the 2015 Provincials. Booking a pool is something that MUST be done at least one year in advance if not 2 years.

Open Water and Long Distance swimming are fast growing sports as is triathlon. MSO would like to have more people volunteering to be on the board of directors or on a committee within the board. MSO is looking to grow and we need people to help us get there.

OFFIALS/MSC REPORTS - Chris Smith

Officials and Masters Swimming Canada Reports October 2012

The current mutually supportive relationship between the Ontario Swimming Officials Association (OSOA) and the members of MSO continues to benefit both organizations and competitive swimming generally in Ontario and elsewhere. As most of you know those of us who compete contribute \$2 per meet and \$5 per championship towards the development of officials' education material by OSOA and support of their education training programs. This plus a group of dedicated technical volunteers has produced excellent training programs on their website which can be downloaded by trainers or taken online. This relationship has both produced many great officials, recognized worldwide; it also ensures a significant commitment from officials for our meets. Some of our members, particularly those who belong to clubs which host meets, are interested in taking these officials training courses both so they can assist their club, also so they can get to know the rules better for their own swimming. OSOA has set up a "masters club" on their website in each of Ontario's six regions. Their system requires that each club have a Club Officials Chair (COC) to manage the clinics, on line or face to face, any deck evaluations and certifications. If any one in your club would like to get involved in officiating, find out more about this program or who the masters COC is in your region please contact me at the email below. The OSOA website is www.osoa.ca if you wish to take a look. With regards Masters Swimming Canada (MSC) they are working on new bylaws which they must produce and approve in order to comply with the new federal Not for Profit Act. They have until October, 2014 to do this and several of us feel this would be a good opportunity to look at our structure, the relationships between our members, clubs, our provincial bodies and other organizations and how these could be improved for the benefit of all. As many of you know MSC was initiated in the 1970s from our involvement with USMS. Canadian Masters had wanted to develop a national body and its component parts that were similar to USMS, perhaps simpler, maybe even better. Due to events in the late 1980s MSC was pushed by others in a very different direction to USMS. Most would agree that this created significant difficulties for MSC in its operations and ability to relate and serve its component parts and members over the following decades. Many feel we now have an opportunity to look at our structure and relationships and make essential adjustments. We need to improve the strength and relevance of our provincial bodies, particularly in our smaller provinces, to develop better communication with them so that we can serve all our members better. This would take some adjustments to our relationships with other aquatic bodies in many provinces, less significantly in Ontario. I have been asked to put some information together on the evolution of MSC and its component parts and its relationships with others, also some thoughts on options we could consider improving these relationships and our ability to serve our members, our sport and our communities. If any one in your club is

interested in finding out more about these issues, if they are interested in getting involved or just want to know more, they can contact me at the email below, I would be happy to give them more information. An adult organization like ours needs a significant number of informed, involved and enthusiastic volunteers to serve it at its various levels. It can be a very rewarding pastime.

We currently have three of us involved with MSC's governance from Ontario; Dave Wilkin is on the Board, Nancy Black is the Executive Director and I am the Council of Provinces representative. I am also the chair of the MSC Rules Committee which includes three other Ontario members; Pat Niblett, Ralph Chown and Bryan Finlay.

15. Business arising from the 2010 AGM Minutes

Doug Vanderby asked if there was any more information on questions he raised last year regarding the need for registration cards for international meets. Mike noted that he had spoken to Lindsay Patten of MSC who indicated there should not be a problem now because all this information may be printed out by the swimmer to present at these meets. He suggested that MSC make it possible to print off a standard registration card so that all swimmers present the same card when required. The Board will look into this and work with MSC to make this happen.

Mike noted that at last year's meeting it was indicated that MSC was going to increase their fees by \$5. per swimmer and that MSO would not be passing this fee increase on to its members. Mike noted that MSC has announced that they will not be increase fees at this time as some of their planned programs did not get off the ground. MSC will review a fee increase at a later date.

Chris Smith suggested that since this is a major financial issue, there should be a motion.
