## **COP/MSC**

A second COP voting Representative to the MSC Board will be voted on at the 2009 Nationals weekend as Glen Mehus is stepping down to run as a candidate for the MSC Board.

Your Vice President has let his name stand for the voting COP representative. Ontario has only one vote on the MSC Board at present. It will be decided by the COP who will vote at meetings. One other COP Member has let his name stand.

Proxy forms , a list of MSC Board Candidates and Bios were posted to the web in April in anticipation of the Ontario Clubs voting at the MSC AGM. This is an excellent use of the web site.

A proposed by-law change has been distributed to Clubs by The Past President of MSC. In essence this proposal would allow the PMO's to vote, a privilege only clubs now enjoy, on a pro rata basis by number of Provincial swimmers. It is proposed that for each 200 swimmers a PMO will have one vote. Ontario would have 16 votes based on current numbers. The smallest Province would have 2 votes.

This would greatly improve the representation of the larger PMOs. It would devalue the vote of the COP, even make its usefulness redundant as the PMOs would take more interest in the MSC matters with their greater voting weight.

## **Swimmer Registration Program**

A new on line Registration System for Ontario Masters Swimmers will be implemented September 1, 2009.

Years ago Masters Swimming Ontario (MSO) created its own software program for registering its members so that it could record name, address, birth date, sex, club and registration number.

The new system will be simple to use and will keep track of member information from year to year with future enhancements like online payments. It will simplify meet registration too.

The first thing necessary is that all MSO Club Registrars verify that they are registered with The MSO Registrar as their Club contact.

We have not received a bid for 2010 Provincials. If we don’t get one VERY soon we will have to cancel for next year. Any suggestions as to how to encourage more clubs to be involved with hosting this great event would be appreciated.

So far I have had no response about the old medals. A box was on display at the awards desk at the Provincials and none have been turned in. We will have to order (very soon) new medals for the 2 provincial OWS championships.

**External Reps**

Swim Ontario – Steve Goodwin

SNC mandates we are members of SO and Masters are insured through SNC at cost of \$2 each although we have our own insurance. Now everyone is aware of this double payment so issue has been brought to light.

SO have announced an OWS, open to Masters; they have to apply for sanctioning from us but we can't sanction because of our insurance restrictions – SO offers a one day registration plus insurance. Michael to investigate with Klaus.

Chris Smith – OSOA/MSO

OSOA has a two day Board meeting starting 10:00 am Saturday which I will be attending, excluding a few hours spent at the MSO Board meeting, so can't report on anything from that. An interesting statistic is that SO has about 360 competitions a year while MSO has about 30.

On related items we are working to resolve issues related to new bathing suit rules and whether lap

counters may be placed in the water with MSC prior to Nationals.

The Canadian Masters OWS Rules are in final draft and hopefully will be approved by MSC this month so that they can be translated, printed and distributed prior to the start of the OWS season.

A suggestion related to the sanctioning of OWS events. Our policy I believe is we try not to have meets in the same area on the same weekend. That policy has been followed with OWS also, and it may not be a good idea. This year we have two sanctioned OWS competitions on the same weekend, Brights Grove and 1000 Island, plus Sudbury holding an OWS, not sanctioned this year but they want to move to a sanctioned meet, also the same weekend. Attendance at OWS events is limited and by having them all on the same weekend we reduce attendance for all. I know there are people in the Toronto area who would go to all, but not if they are on the same weekend. Something to think of for the future!

I understand there was a very informative discussion at the recent Swim Ontario meeting on issues regarding MSOs relationship with Swim Ontario, the \$2.00 fee, insurance. I believe there are real opportunities for a resolution that would have beneficial implications for Masters in Ontario and across Canada. I look forward to Steve's report.

MSC also meets this weekend, a Sunday night teleconference so can't report from that either. Lindsay is back so a few issues that have been on hold should move forward. I think it would be very useful to have a good discussion on Saturday about the relationship between the provincial master's organizations, in particular MSO, and MSC. Also how COP works as the connection, communication link and the body that carries the provincial authority to the national level. The rational and timing issues related to changing the By-Laws to define a PMO and provide a far more direct relationship between MSC and the PMOs.

Need an insurance certificate to show SO to prove we are covered. Suggest we take \$5k of the \$6k we are paying for insurance, offer it to SO for swimmer development try to improve relationship.

The purpose of the proposed new bylaw is to strengthen the national body by involving the smaller provinces – we need to support the bylaw
