The AGM was scheduled to take place during the 2019 MSO Provincial Championship on March 28, 2020. The Championship was postponed due to the COVID-19 outbreak. Certain AGM formalities needed attention and these were brought to the membership via email. The following outlines the actions taken to hold MSO's 2019 AGM.

- January 12 ,2020 - First Notice of the 2019 AGM and Call for Nominations  
Sent to all members, both swimmers and voting clubs  
(Attached below along with a subsequent correction of the time of the meeting)
- February 14, 2020 – Second Notice of the AGM and Call for Nominations (Reminder)  
Sent to all members, both swimmers and voting clubs
- February 15, 2020 – Nominations were closed; the Nomination Committee prepared its report; all candidates for the BoD would be acclaimed. The report outlined the process for receiving additional BoD members.
- February 28, 2020 – Members, informed that the AGM documents were published to the website. Subsequent to publication, one BoD nominee withdrew. An additional nominee was received. The final list of nominees was published March 15<sup>th</sup>.
- March 13, 2020 – the MSO Provincial championship was postponed due to the COVID-19 outbreak. The Notice to all members, swimmers and clubs, included instructions for Absentee Voting process on the two motions before the membership. (Reproduced below).
- April 1, 2020 – Absentee Voting package sent to all Club Presidents and Club Contacts. A reply by April 10<sup>th</sup> requested. An error in the club voting weights was subsequently brought to MSO's attention and corrected before the votes were tallied.
- April 10, 2020 – Absentee voting was tallied and both motions were passed.

### 1. MSO Provincials Postponed
